Item 6: Entrant Restrictions	Entrants must be resident in Australia and log in to the Website as a member of the Bonds Rewards loyalty program. In order to use a discount offer won in the Promotion, winners must be aged 18 years or older, or have the permission of their legal parent or guardian who is aged 18 years or older, at the time of redemption.

Terms and Conditions

1. INTRODUCTION

- 1.1 By submitting an entry into this Promotion, entrants warrant that they have read, understand and agree to be bound by these Terms and Conditions and the Terms and Conditions Schedule.
- 1.2 To the extent that there is any inconsistency between the Terms and Conditions Schedule and these Terms and Conditions, the Terms and Conditions Schedule will prevail.
- 1.3 References in these Terms and Conditions to Items are references to the corresponding Item in the Terms and Conditions Schedule.

2. DURATION

The Promotion will run for the period specified in Item 5: Promotion Period.

3. ELIGIBILITY

- 3.1 Entrants must at all times comply with Item 6: Entrant Restrictions. Those entrants who have not complied with Item 6: Entrant Restrictions will be disqualified.
- 3.2 Employees and their immediate families of the Promoter and its related bodies corporate, and of all associated sponsors and participating companies are ineligible to enter.
- 3.3 Entrants warrant that they are entering the Promotion in a wholly private nature and are not entering on behalf of a business or enterprise activity they are involved in.

4. METHOD OF ENTRY
